Reaffirmation of San Francisco Labor Council's Commitment to Immigrant Workers and Families

Whereas, the SFLC has steadfastly supported the rights of immigrant workers and their families including the extension of DACA (Deferred Action for Childhood Arrivals); and

Whereas, if the rights of some workers are attacked, the rights of all workers are weakened; and

Whereas, federal funding for the City of San Francisco may come under attack due to its status as a sanctuary city,

Therefore be it Resolved that the SFLC hereby reaffirms its commitment to defend the rights of immigrant workers and their families; and

Therefore be it Further Resolved that the SFLC will take steps to publicize its support for our immigrant sisters and brothers, and our support for San Francisco's status as a sanctuary city; and

Be it Finally Resolved that the SFLC create a text/phone tree of delegates who commit to being part of an emergency response network in defense of immigrant rights.
